23 The Court having considered the Motion (the “Motion”) of David A. Gill, the
24 Permanent Receiver (the “Receiver”) in the above-captioned case (the “SEC
25 Action”), For Authority to Employ and Pay Bryan, González Vargas & González
26 Baz, S.C. (“Bryan-González”), set for hearing on November 16, 2009, no opposition
27 having been made, and good cause appearing:

1 IT IS HEREBY ORDERED THAT:

2 1. The Receiver's Motion is granted.

3 2. The Receiver is authorized to employ Bryan-González as his special
4 counsel, retroactive to August 1, 2009, as an administrative expense of the
5 receivership estate in the SEC Action pursuant to the terms of the engagement letter
6 attached as Exhibit 2 to the Motion.

7 3. The Receiver is authorized to pay Bryan-González, fees in the amount
8 of \$5,801.25 and costs of \$580.13.

9 4. The Receiver is authorized to pay Bryan-González, a retainer of \$10,000
10 to be held by Bryan-González as security for payment of its fees and costs which are
11 allowed by the Court and revolving fund for costs of \$2,000 as set forth in the
12 engagement letter attached as Exhibit 2 to the Motion.

13 5. Except as set forth in paragraph 3 hereof, Bryan-González shall be paid
14 its fees and costs, based on its normal hourly rates and cost schedule, after notice
15 served on the Limited Service List, a hearing and approval of the Court.
